4.1 FORMAL WELCOME

Wendy Boje, RAC Chair

- The RAC Chair formally opened the fourth RAC Session in Banff, Alberta, and thanked RAC members for providing feedback between sessions and for the work they are doing around landuse planning.
- RAC reviewed the Minutes of the third session from Rocky Mountain House, Alberta.

4.2 RAC DISCUSSION ON THE DRAFT ADVICE FOR THE RECOMMENDATION REPORT

RAC

- RAC reviewed the draft advice from the second and third sessions for the RAC Recommendations Report.
 - RAC provided feedback and supplemental perspectives to be considered when RAC reviews the full Recommendations Report in the sixth session.

4.3 BIODIVERSITY MANAGEMENT AND STEWARDSHIP ON PRIVATE LANDS

- ARD presented on <u>Biodiversity Management and Stewardship on Private Lands</u>, which included an overview of the following:
 - Context setting, current state, and the role of private land owners in stewardship and conservation in the North Saskatchewan Region
 - Existing policies and approach
 - Opportunities and challenges for achieving biodiversity goals
 - Analysis for RAC consideration a series of conversations to obtain RAC's feedback around what the government is doing

4.4 RAC ADVICE ON BIODIVERSITY MANAGEMENT AND STEWARDSHIP ON PRIVATE LANDS

RAC

Through a facilitated discussion, RAC engaged in the first three, in a series of five, conversations around biodiversity management and stewardship on private lands. The discussions centered on "Enhancing Existing Tools," an "Online Stewardship Tool," and a "Collaborative Public Awareness Campaign to Recognize Stewardship on Private Lands." RAC members provided comments, considerations, and suggestions on these topics areas and where the Government of Alberta should focus its efforts.

4.4 RAC ADVICE ON BIODIVERSITY MANAGEMENT AND STEWARDSHIP ON PRIVATE LANDS (continued...)

RAC

- RAC continued its facilitated discussion around the fourth and fifth conversation areas to address biodiversity management and stewardship on private lands. RAC members reviewed the government's proposed "Locations of Future Pilot Projects," and suggested some new options for pilot locations. RAC members provided advice to the Government of Alberta on which pilot projects should be prioritized along with the rationale behind each recommendation. In the fifth and final conversation area RAC suggested potential new approaches and tools for consideration.
- RAC achieved consensus on the recommendations, and related considerations, for the Government of Alberta to address biodiversity on private lands in the North Saskatchewan region.

- The Assistant Deputy Minister (Parks Division) of Tourism, Parks and Recreation (TPR) gave a summary of the ministry's mandate, activities, and direction, and RAC members provided comments and feedback for consideration.
- TPR presented on <u>Outdoor Recreation: Management of Recreation on Crown Land</u>, which included an overview of the following:
 - Context setting and current state of outdoor recreation in the North Saskatchewan
 Region
 - Existing policies
 - Opportunities and challenges
 - Approaches for management of Crown land and expansion or establishment of new recreation areas
- RAC members engaged in a round table to explore new ideas on how to improve the outdoor recreation experience of Albertans.

4.7 OUTDOOR RECREATION: MANAGEMENT OF RECREATION ON CROWN LAND (continued...) Chris Spytz, TPR

TPR continued the presentation from the previous day on <u>Outdoor Recreation: Management of Recreation on Crown Land</u>, and presented RAC with three approaches for "Management of Crown Land and Expansion or Establishment of new Recreation Areas."

- The three approaches were:
 - Recreation management planning on Crown Land
 - Invest new funds to enhance and upgrade the existing provincial parks system
 - Add new land base to the provincial parks system

4.8 RAC ADVICE ON OUTDOOR RECREATION

RAC

- For each of the three approaches, RAC members discussed and provided feedback for government consideration on every one of the proposed areas. RAC advice included implementation considerations and possible solutions to help address the issue of increasing demand for outdoor recreation opportunities in the province.
- RAC members were asked to prioritize as a group, the most important areas they felt the Government of Alberta should focus on for each approach.
- For the first approach, 'Recreation management planning on Crown Land,' RAC members were presented with seven proposed regions under consideration as future recreation areas in the

province. Four regions were selected as priority areas for the government to focus on.

- The second approach, 'Invest new funds to enhance and upgrade the existing provincial parks system,' three regions were prioritized well ahead of the others.
- The third approach, 'Add new land base to the provincial parks system,' provided RAC members with maps and the rationale behind the selection of 13 proposed areas in the North Saskatchewan Region. They were asked to review each as a potential new recreation area or expansion upon an existing area based on a set of criteria for evaluation.
 - RAC reached consensus on 7 of the 13 proposed areas for expanding existing or establishing new recreation areas for Albertans. RAC provided additional implementation considerations and contrasting perspectives for the remaining six recreation areas.
